* This is a one-day tournament with a 3-game guarantee. The tournament will include fourth through sixth grade with two divisions (Blue and White) per grade level. *

Divisional Play

Teams will be placed in either the Blue Division or the White Division based on level of competition. We will make every attempt to place teams in the appropriate division to create competitive balance.

Sport Equipment

Each team is responsible for bringing their own practice balls.

All competitors must wear a team uniform. Uniform shirts must be numbered and identical color. Each team must have two different colored uniform shirts available.



II. COMPETITION FORMAT

Bracketing

Two pool play games followed by at least one bracket game for each team will be followed by a single elimination tournament. Each bracket will have a championship game.

Scheduling

One day of competition. Please see App Tourney for details. **There is a 15-minute forfeit rule in effect.** Forfeited games will be recorded as 20-0 to the opposing team.

Awards

We will award the first place team in each division. Additional awards will be given to first and second place teams in each division (1st - 2nd). All registered members of the placing teams, who are present at the event, will receive a "Mike's Got This!" T-shirt.



III. SPORT RULES

A team must begin the game with five (5) players, but if it has no substitutes to replace disqualified players, it may continue with fewer than five (5). A team will forfeit the game if there are less than four players on the court.

Each game will consist of two 20-minute halfs of running time. The game clock will be stopped during all dead-ball periods in the last 2 minutes of the 2nd half and any extra periods. The game clock will be stopped during all time-outs. Overtime will consist of a 2-minute period. The game clock will be stopped during all dead ball periods. If the teams remain tied after the first overtime period. The winner will be determined by the first team to score.

Pre-Competition Meeting

Prior to the start of competition, a meeting will be held between the referees and the captain or coach from each participating team to clarify rules and conduct of play. Details of this meeting will be shared in the Sport Confirmation Letter.

Players Conduct

Any serious violation of conduct, such as fighting or violence toward players or officials, by players, coaches or fans, will result in that person's immediate ejection from the facility and his/her automatic ejection for the remainder of the tournament. The sport coordinator shall immediately notify the DM Injury Law, who will investigate each incident to determine if additional discipline will be imposed.
