

The **DM Law Foundation** recently awarded grants for new equipment, uniforms and other resources to loca high school football programs throughout the Kansas City metro area.

This year, the DM Law Foundation's equipment grant program awarded almost \$80,000 in resources to benefit young athletes based on need, merit, and the organization's commitment to coaching education and best practices. This grant directly benefited more than 21 high school football teams in Kansas City, Missouri; Kansas City, Kansas; and the Topeka, Kansas Public School Systems. Since 2022, the foundation has provided more than \$400,000 in resources to help young athletes.

Grants are valued from \$999 to \$30,000, and help provide resources from the DM Law Foundation:

Their holistic approach aimed to bring stability and dignity to children navigating the foster care system, making a tangible difference in their lives.
